### Role & Responsibilities:

As a Board Director at Babies of Homelessness, your leadership, expertise, and dedication will be integral to our ongoing success and growth. Board members are expected to uphold the organization's values, ensuring that we effectively address the needs of our community while sustaining the mission of BoH.

Key responsibilities include:

**Time Commitment:**

Board members are required to attend at least 90% of all board meetings, committee meetings, and special events. Our board meetings take place every other month on the third Tuesday from 5-7 PM on the Eastside, with in-person attendance preferred. We also hold an annual retreat to review strategic goals, and committee meetings are scheduled as needed by committee chairs. In addition to meeting attendance, board members are expected to dedicate at least 5 hours each month to support our initiatives. This time commitment includes attending meetings, responding to emails, voting on key decisions, participating in committee work, conducting research, attending training sessions, and supporting events.

**Leadership:**

You are a proven leader in team settings and have experience serving on other boards. Board members may be asked to lead a committee, and your project management and organizational skills will be crucial in getting results and driving the initiatives of the organization forward. We seek individuals who are capable of managing multiple tasks, motivating teams, and delivering outcomes aligned with the organization's strategic goals.
